# Illuminated Powertrain Temperature Warning Lamp With Diagnostic Trouble Code (DTC) P0A3C:94 In The SOBDMB And/Or SOBDMC

2022-2023 F-150 Lightning

**Issue:** Some 2022-2023 F-150 Lightning vehicles may exhibit an illuminated powertrain temperature warning lamp accompanied by a Motor Coolant Over Temperature message in the instrument panel cluster (IPC) with DTC P0A3C:94 stored in the secondary on-board diagnostic control module B (SOBDMB) and/or the secondary on-board diagnostic control module C (SOBDMC). This may be due to the software within the SOBDMB and/or SOBDMC. To correct this condition, follow the Service Procedure to bring both modules to the latest software level.

Action: Follow the Service Procedure to correct the condition on vehicles that meet all of the following criteria:

- 2022-2023 F-150 Lightning
- DTC P0A3C:94 in the secondary on-board diagnostic control module B (SOBDMB) and/or secondary on-board diagnostic control module C (SOBDMC)

**Warranty Status:** Eligible under provisions of New Vehicle Limited Warranty (NVLW)/Service Part Warranty (SPW)/Special Service Part (SSP)/Extended Service Plan (ESP) coverage. Limits/policies/prior approvals are not altered by a TSB. NVLW/SPW/SSP/ESP coverage limits are determined by the identified causal part and verified using the OASIS part coverage tool.

#### **Service Procedure**

- **1.** Reprogram the SOBDMC using the latest software level of the Ford Diagnosis and Repair System (FDRS). Follow all on-screen instructions carefully to complete all coordinated module software updates.
- **2.** If a software update is available, reprogram the SOBDMB using the latest software level of the FDRS. Follow all on-screen instructions carefully to complete all coordinated module software updates.
